



## ORAL FLUID AND URINE DRUG TESTING

Over the past year, MD Labs has witnessed many changes in payer medical policy regarding Oral Fluids and Urine Drug Testing. The charts below outline which level HCPCS Codes are payable by the payer. When ordering Oral Fluid and Urine Drug Testing please keep in mind the payer’s coding policies, and only order what is medically reasonable and necessary for the patient’s treatment.
